# Program Presentation: Just for Girls, Girls Alternative Program to Success (GAPS)

Becky Canesse and Drena Green introduced the Girls Alternative Program to Success (GAPS), which serves exclusively girls, provided a history on the GAPS program, and provided the program's status. Ms. Green detailed the program's services which include academic success, behavior modification, community engagement, and activity enrichment. Ms. Green presented a PowerPoint and fielded questions from CSAB members.

# Program Presentation: Just for Girls, Stepping Up to Success (SUS)

Drena Green presented the Just for Girls' Stepping Up to Success (SUS) program which serves exclusively-girls, provided a historical overview of the SUS program, and provided updates on the program's status. Ms. Green discussed the range of services offered by the program, including academic support, social assistance, at-risk prevention, behavior modification,

# Program Presentation: Family Resources, Community Effort to Reduce Truancy by Assessing Individualized Needs (CERTAIN)

Andy Coble of Family Resources, CERTAIN program, presented the program's history and offered an update on its status. Mr. Coble outlined the services provided by the program, including academic success, referral processes, collaborations with local agencies, and truancy prevention. During the presentation Mr. Coble shared a program brochure and addressed questions from CSAB members.

#### **Program Presentation- Family Resources; SafePlace2B**

Andy Coble of Family Resources, SafePlace2B program, delved into the program's history, purpose, and provided a program status update. Mr. Coble detailed the services available through the program encompassing crisis intervention, at-risk prevention, emotional and social counseling, counseling groups, and safety plans. As part of the presentation Mr. Coble distributed a program brochure and responded to inquiries from CSAB members.
