Melissa Bomar provided the following updates:

- Continuing to execute contracts.
- Currently working to schedule and conduct Results First Reviews.
- Boys and Girls Club voiced some uncertainty about the new program "Lalilo".
 - Research indicates it is a comprehension, phonics, grammar, and reading activity platform for students in grades 3-6 who have not mastered foundational literacy skills.
- No concerns to report currently.

Brenda Marquez-Facio provided the following updates:

- Accompanying staff to attend site visits to be introduced to the program staff and learn about the programs.
- There are no issues or concerns to report currently.

Kristi Hagen provided the following updates:

- Shared the purpose of the Results First Reviews is for staff to confirm the program/agency is tracking the milestones as stated in the verification method, and to confirm the agency has an appropriate method to accurately compile the information for required quarterly reporting.
