A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MANATEE COUNTY, FLORIDA, ESTABLISHING SPECIFIC FINE AMOUNTS FOR CERTAIN VIOLATIONS OF ANIMAL ORDINANCE 22-16, AS AUTHORIZED BY SEC. 2-4-24; RESCINDING RESOLUTION R-12-151; PROVIDING AN EFFECTIVE DATE.

WHEREAS, MANATEE COUNTY adopted Ordinance 22- 16 (Animal Ordinance); and

WHEREAS, the Animal Ordinance provides that the Board of County Commissioners establish, by resolution, the civil penalty for a civil infraction; and

WHEREAS, unless specifically provided, any person cited for an infraction of the Ordinance shall pay a civil penalty of One Hundred (\$100.00) Dollars for the first offense, Two Hundred (\$200.00) Dollars for the second offense, and Three Hundred (\$300.00) Dollars for the third offense;
