Discussion ensued on previously failed motion 61, to fund the requested amount of \$76,400 for a new FY23 Program standing #51, Palmetto Youth Center, Seeds to Serving Program. Motion 61 failed and program was not recommended for funding. **Rationale:** Premature request for funding, it is not organized enough, not clear what the program entails. CSAB members had the impression that the agency representative was not sure as to what the program would entail. CSAB members love the concept and there is good potential with a focus on middle schoolers and bringing in a chef to support. Program selected the literacy priority, it is unclear how it would move the needle on the literacy gap if the focus is on healthy eating. CSAB members recommended the program conduct a pilot and return to reapply for funding in the next application cycle for FY24.

Discussion ensued on the previously failed motion 32, to fund the requested amount of \$225,000 for Program standing #52, Galatians 6:2 Inc. dba Avenue941, Manatee Assisted School health (MASH) Initiative. Motion 32 failed and program was not recommended for funding, CSAB members provided their rationale for not recommending funding. **Rationale**: CSAB members are unsure as to what the funds will be utilized for, low score, support for the idea but didn't match the Results 1st matrix, cost per client is high, no pre- or post-assessments administered to determine client gains from program and milestones are not formulated clearly. CSAB members are hopeful the program will improve their results and reapply next year.

Motion 61 failed and program was not recommended for increased investment. **Rationale**: CSAB members previously reviewed during funding review meetings and program did not meet threshold for increase funding recommendation consideration on the CSAB Decisions Making Guide-Request for Increased Investment flowchart.

Discussion ensued amongst CSAB members concerning the significant increase of the Consumer Price Index and the statute on minimum wage. It was determined this will be discussed at a future meeting or during the annual retreat.

Motion Number 63 **Motion:** Adopt FY23 investment recommendations made on May 23, 2022, and May 25, 2022, totaling \$13,440,532, **Action:** To Approve **Moved by** Jennifer Hamey **Seconded by** Jannon Pierce, **Public Comment:** Anna Cismesia spoke of experience with Centerstone's Sexual Assault Child Advocacy and Therapy program and need for the program when she found out two of her children were victims of sexual battery. Spoke highly on behalf of the services and dedication that were provided. Sexual assault is an unknown, no one ever knows when it is going to happen. Requested the CSAB to reconsider and withdraw this motion and make a motion to provide the additional increase requested by Centerstone for the Sexual Assault Child Advocacy and Therapy program. **Motion withdrawn**.
